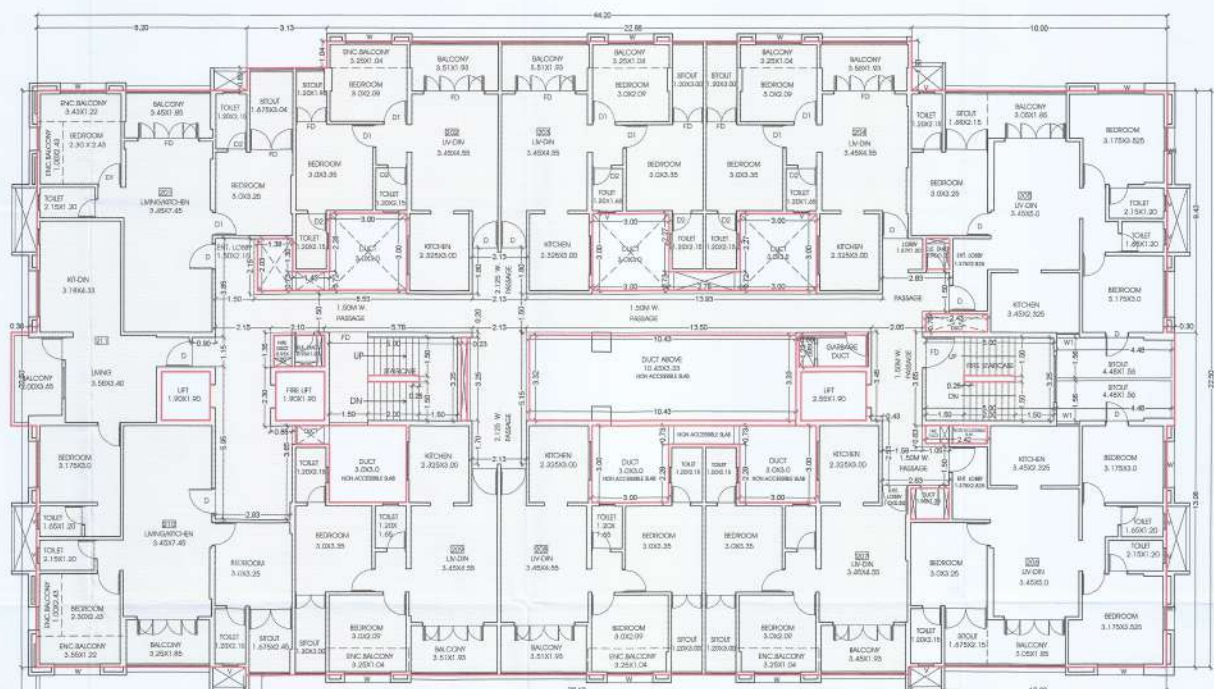

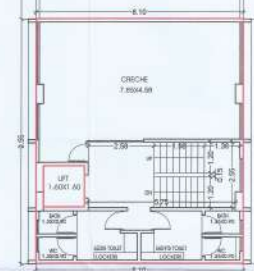

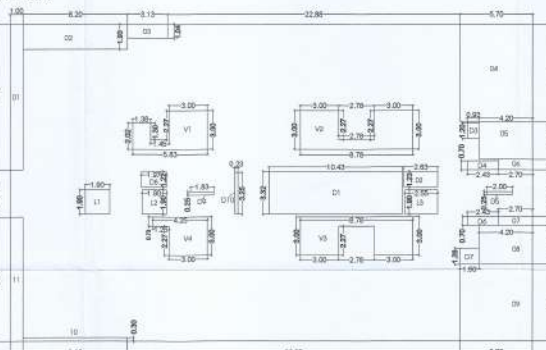


SECOND FLOOR PLAN

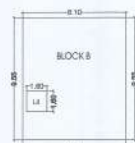

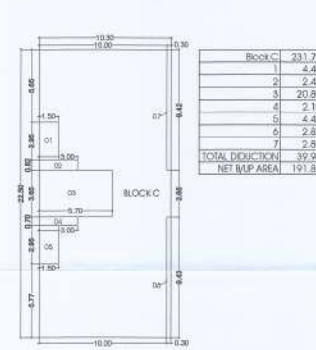
